CALL FOR ABSTRACTS

An extended abstract (at least one, but no more than two full pages), accompanied by the relative Abstract Form, should reach the Organization no later than 31st January 2012. Abstracts must show the full title of the paper, names, affiliation, e-mail address and full mailing address of all the Authors. Abstracts must clearly present background, objectives, methodology and results on a sound basis (innovative case studies, research data, practical experiences, investigations etc.). The author who will present

the paper at the Conference should be clearly indicated. In the Abstract Form the suggested topic and the requested destination (oral or poster) must be indicated.

Each Leading Author may submit no more than three abstracts. Authors are expected to attend the Conference and present their papers themselves.

The official language of the Conference will be English.
